The Director contributes, in the area of Space Transportation, to forming the "Team of Teams" at senior management level.</p> <p>In the framework of the ESA matrix organisation comprising programme directorates and support directorates, the Director of Launchers, under delegation from the Director General, is responsible for the preparation and implementation of the Agency's launcher programmes, for contributing to the future of the European launcher sector consistent with the European Space Policy, as well as for the preparation of proposals for preparatory and new development programmes, respectively.</p>
<b>QUALIFICATIONS</b>	<p>Applicants for this post should have a higher, preferably technical or scientific, education coupled with in-depth knowledge and experience in functions similar to those described above, preferably acquired in an international setting.</p> <p>Key qualities required for the post are an innovative spirit and a strategically-oriented mind, a proven capacity to lead change and manage people and teams, excellent relationship management and negotiation skills and the ability to influence high-level decisions.</p>
