<sup>1</sup> The **place of employment** of the Staff Member shall be at the offices of the Agency in Prague, Czech Republic, subject to changes in the interest of the service and always under due consideration of the Staff Member's interests.

<sup>2</sup> **Five-year contract** with the possibility of a renewal for a fixed period and a further renewal for an indefinite period on the conditions set out in the Staff Regulations and in the Conditions of Employment for Other Servants.

<sup>3</sup> The hierarchical **reporting line** may change in line with the developments of the GSA and department's organisation. The successful candidate might be placed within the GALILEO Exploitation Department reporting operationally to a manager of the exploitation team in a matrix organisation.

<sup>4</sup> The successful candidate must hold a valid personnel security clearance at the above defined EU level or be able and willing to apply for a security clearance immediately after the contract award. The procedure for obtaining a personnel security clearance shall be initiated on request of the employer only, and not by the individual candidate.



## 1. POST CONTEXT

### SECURITY DEPARTMENT

The GSA Security Department proactively contributes to the fulfilment of GSA missions by providing the security expertise in order to (1) achieve successful security accreditation of the systems, (2) secure programmes' implementation and exploitation and (3) ensure a wide, secure and sustainable use of the Public Regulated Service (PRS).

In order to secure the programme's implementation and exploitation, the Security Requirements and Standards Team of the Security Department manages both the support to the European Commission in exercising its responsibilities related to security and to support and liaise with the Galileo and EGNOS exploitation programme teams in the Agency.

In particular, the team provides security support to the Galileo Exploitation team for the engineering and operational activities required for the provision of the GNSS (Galileo and EGNOS) services.

### GALILEO EXPLOITATION DEPARTMENT

The role of the European GNSS Agency, in the Galileo exploitation phase, shall include tasks in particular as follows:

- (i) Operational activities of the Galileo Programme including system infrastructure management, maintenance, on-going improvement, accreditation and standardisation, as well as services provision
- (ii) Development and deployment activities of the evolution and future generations of the systems, including procurement activities

The Galileo Exploitation team is in charge of managing the exploitation phases of the Galileo Programme, and shall in particular:

- Manage the execution of the Galileo exploitation phase in compliance with the EC-GSA delegation agreements, controlling the associated schedule, costs and risks
- Analyse, define and implement the Galileo exploitation concept
- Manage the Galileo infrastructure operations, maintenance, protection, on-going improvement and evolutions activities, through associated contracts and/or working arrangements
- Manage the standardisation activities associated with the Galileo Programme
- Manage the operational interfaces and services provision to the Galileo users
- Liaise with the GSA Market Development Department for the services adoption and continuous improvement of the Galileo use
- Liaise with the GSA Security Department and Security Accreditation Board for ensuring the accreditation of the Galileo systems and services
- Liaise with the relevant authorities to ensure certification of the Galileo systems and services
- Liaise with the EC and ESA for all matters dealing with the Galileo exploitation-related activities

The Galileo exploitation phase will start with the provision of the so-called Initial Services in 2016. The exploitation phase will start beginning of 2017, when the Galileo Systems infrastructure will be transferred from ESA to GSA through EC, and services provision will be managed directly by the GSA. The Galileo deployment is planned to be completed in parallel to the exploitation phase by 2020, when the Space Segment will have been fully deployed and all services will be declared fully operational (FOC).



## 2. TASKS AND RESPONSIBILITIES

The Galileo Security Engineer shall report to the Security Requirements and Standards Manager of the Security Department and carry out the tasks that will be assigned to him/her, in particular regarding the two main areas of:

- Security engineering support to Galileo Exploitation activities
- Security support to the exploitation and implementation of the Galileo services (including PRS)

The tasks and responsibilities shall in principle include (without limitation):

- Support to the analysis, review and maintenance of the Galileo security requirements baseline according to the different Galileo programme and service milestones and evolutions
- Support to the handling of the Galileo Service Operator (GSOp) security-related activities
- Support to the review and maintenance of the GSOp security-related documentation
- Support to the analysis, review and maintenance of the Galileo security requirements and documentation related to the Galileo Service Centre (GSC), Galileo Reference Centre (GRC) and other facilities under responsibility of the GSA
- Support to the definition of security requirements related to the implementation of Galileo services (including Open Service, Commercial Service, Public Regulated Service) and the relevant implementation follow-up
- Support to the follow-up of the current Galileo operations contracts and assess the impact of changes in the security and in security operations on the GSOp baseline
- Liaise with the GSA Exploitation and Galileo Security Monitoring Centre (GSMC) teams and provide security engineering support upon request and according to their needs as reflected in the Agency Annual Work Programme
- Contribute to the maintenance and update of the Statement of Compliance to the applicable security requirements in cooperation with the GSMC and ESA
- Support the coordination of the security requirements with the overall exploitation requirements baseline in support to the Exploitation team
- Participate to Galileo technical reviews related to security aspects
- Contribute to the preparation of accreditation files and security risks analyses for the exploitation phases of Galileo and the associated risks treatment plans in cooperation with ESA
- Follow up of the implementation of the security requirements and of the risk treatment plans
- Technical support to the Commission on the GNSS Security Board and associated working groups;
- Draft technical notes and reports on Galileo system and service security aspects
- Contribute to the implementation and improvement of the security requirement and standard processes
- Contribute to the definition of requirements for the evolutions of the Galileo system, operations and services
- Assist the Security Requirements and Standards Manager in the management of the contracts providing security support to the team



### 3. PROFESSIONAL QUALIFICATIONS AND OTHER REQUIREMENTS

#### A. ELIGIBILITY CRITERIA

The selection procedure is open to applicants who satisfy the following eligibility criteria, on the closing date for application:

1. A level of education which corresponds to completed university studies<sup>5</sup> attested by a diploma when the normal period of university education is four years or more,  
**OR**  
A level of education which corresponds to completed university studies attested by a diploma and at least one year of appropriate professional experience when the normal period of university education is three years
2. In addition to the above, appropriate professional experience<sup>6</sup> of at least **six years**
3. Be a national of a Member State of the European Union or Norway
4. Be entitled to his or her full rights as citizen
5. Have fulfilled any obligations imposed by the applicable laws concerning military service
6. Meet the character requirements for the duties involved<sup>7</sup>
7. Have a thorough knowledge of one of the languages of the European Union<sup>8</sup> and a satisfactory knowledge of another language of the European Union to the extent necessary for the performance of his/her duties
8. Be physically fit to perform the duties linked to the post<sup>9</sup>

<sup>5</sup> Only study titles that have been awarded in EU Member States or that are subject to the equivalence certificates issued by the authorities in the said Member States shall be taken into consideration.

<sup>6</sup> Only appropriate professional experience acquired after achieving the minimum qualification stated in A.1 shall be considered. Where additional periods of training and study are accompanied by periods of professional activity, only the latter shall be considered as professional experience. Compulsory military service or equivalent civilian service accomplished after achieving the minimum qualification stated in A.1. shall be taken into consideration. Internships will be taken into consideration if they are paid. Professional activities pursued part-time shall be calculated pro rata, on the basis of the percentage of full-time hours worked. A given period may be counted only once.

<sup>7</sup> Prior to the appointment, the successful candidate will be asked to provide a Police certificate confirming the absence of any criminal record.

<sup>8</sup> The languages of the EU are: Bulgarian, Croatian, Czech, Danish, Dutch, English, Estonian, Finnish, French, Irish, German, Greek, Hungarian, Italian, Latvian, Lithuanian, Maltese, Polish, Portuguese, Romanian, Slovak, Slovene, Spanish, Swedish.

<sup>9</sup> Before a successful candidate can be appointed, s/he will be medically examined by a selected medical service so that the Agency will be satisfied that s/he fulfils the requirement of Article 28(e) of the Staff Regulation of Officials of the European Union.



## **B. SELECTION CRITERIA**

All eligible applications, according to the afore-mentioned criteria (part A), will be assessed against the requirements listed below.

Please note that non-compliance with at least one of the Essential requirements (B.1) will result in the exclusion of the candidate from the selection process.

Advantageous requirements (B.2) constitute additional assets and will not result in exclusion, if not fulfilled.

### **1) Essential qualifications and experience**

- i. University degree in the exact sciences (e.g. engineering, physics, mathematics, computer science, telecommunications, electronics etc.)
- ii. Proven experience relevant to the tasks described above
- iii. Experience in security engineering, including secure design, operations, implementation and/or security risk assessment
- iv. Experience in engineering activities related to GNSS, space or complex projects
- v. Excellent command of both written and spoken English
- vi. Proven abilities to use electronic office equipment (e.g. word processing, spreadsheets, email, internet, etc.)

### **2) Advantageous qualifications and experience**

- vii. To already hold a security clearance at the level of SECRET UE/EU SECRET (or equivalent)
- viii. Knowledge (by training or experience) of the security aspects of the European GNSS programme
- ix. Experience of Galileo system design and implementation
- x. Experience in service provision

### **3) Behavioural competences**

- xi. Motivation
- xii. Communication skills
- xiii. Working with others
- xiv. Stress management & flexibility
- xv. Analysis & problem solving
- xvi. Prioritising and organising

## **4. SELECTION PROCEDURE**

The selection procedure includes the following steps:

- After registration, each application will be checked in order to verify that it meets the eligibility criteria.
- All eligible applications will be evaluated by a Selection Board based on the selection criteria defined in this vacancy notice.
- The best-qualified candidates, those who obtained the highest number of points within the evaluation, will be short-listed for an interview. The minimum threshold is 65% of the total points.



- During the interview, the Selection Board will examine each candidate's profile and will assess their relevancy for this post. In order to support the evaluation via interview, shortlisted candidates will be required to undergo written tests relevant to the job content (the minimum threshold for this test is 50% of the total points allocated for it) and to complete part of the process in their second EU language. All candidates short-listed for an interview will also be requested to complete an online Business Attitude Questionnaire.
- Candidates will be requested to bring with them on the day of the interview photocopies of all the supporting documents for their educational qualifications and employment necessary to prove that they meet the eligibility criteria. GSA has the right to disqualify applicants who fails to submit all the required documents.
- As a result of the interviews, the Selection Board will recommend the most suitable candidate(s) for this post to be placed on a reserve list. The minimum threshold to be placed on the reserve list is 65% of the total points.
- The best ranked candidates will be invited for an interview with the Appointing Authority. The interview will focus on the overall suitability of the candidate for the post covering motivation, relevant technical and behavioural competencies, in line with the selection criteria established in the vacancy notice.
- The Appointing Authority may ultimately decide on the successful candidate to be appointed to the post.
- The established reserve list may also be used for recruitment of similar posts depending on the Agency's needs. Where a similar post becomes available, the Appointing Authority may select applicants from the list according to their profile in relation to the specific requirements of the post to be filled. However, inclusion on the reserve list does not guarantee recruitment.
- If, at any stage of the procedure, it is established that any of the information the candidate provided is incorrect, the candidate in question will be disqualified.

- Fully completed, pointing out the professional experience relevant to this position (incl. calculation of years, months)
- Printed, signed and clearly scanned in (in one single document)

The application will be rejected if it is not duly completed and signed.

No documents will be sent back to candidates.

## 6. APPEAL PROCEDURE

If a candidate considers that he/she has been adversely affected by a particular decision, he/she can

- lodge a complaint under Article 90(2) of the Staff Regulations of Officials of the European Communities and Conditions of employment of other servants of the European Communities, at the following address:

Please note that complaints made to the Ombudsman have no suspensive effect on the period laid down in Articles 90(2) and 91 of the Staff Regulations for lodging complaints or for submitting appeals to the Civil Service Tribunal under Article 270 of the Treaty on the Functioning of the EU (ex Art. 236 TEC). ## 7. SUMMARY OF CONDITIONS OF EMPLOYMENT

### I. FINANCIAL ENTITLEMENTS

The remuneration consists of a basic salary<sup>11</sup> and, where applicable, additional allowances<sup>12</sup>, paid on a monthly basis and reimbursements<sup>13</sup>, paid upon their evidenced occurrence.

The sum of the basic salary and the applicable additional allowances is weighted by the correction coefficient applicable for the location of the post<sup>14</sup>. The sum of usual social deductions from salary at source is subtracted from the weighted amount<sup>15</sup>. The full pay is exempted from the national income tax, but is subject to the internal income tax and the solidarity levy<sup>16</sup>.

Examples of net monthly salaries (as currently applicable in Prague) are presented below:

### II. LEAVE ENTITLEMENTS

Staff is entitled to annual leave of two working days per each complete calendar month of service plus additional days for the grade, age, home leaves for expatriates and an average of 16 GSA public holidays per year.

Special leave is granted for certain circumstances such as marriage, moving, elections, birth or adoption of a child, serious sickness of spouse, etc.

### III. SOCIAL SECURITY

The pension scheme provides a very competitive pension after a minimum of 10 years of service and reaching the pensionable age. Pension rights acquired in one or more national schemes before starting to work at GSA may be transferred into the EU pension system.

GSA's benefits include an attractive Health insurance: staff is covered 24/7 and worldwide by the Joint Sickness Insurance Scheme (JSIS). Staff is insured against sickness, accident and occupational disease, and could be entitled to unemployment and to invalidity allowances.

### IV. PROFESSIONAL DEVELOPMENT AND BENEFITS CONTRIBUTING TO WORK-LIFE BALANCE

GSA aims at creating and maintaining a supportive and healthy work environment that enables staff members to have balance between work and personal responsibilities, for example through flexible working time arrangements.

GSA also offers a wide range of training courses to develop staff members' personal skills and keep in touch with the latest developments in their field. The training and professional development opportunities are attuned to the career plan and requirements of the departments.

## 8. COMMITMENT

### Declaration of commitment to serve the public interest independently:

The jobholder will be required to make a declaration of commitment to act independently in the public interest and to make a declaration in relation to any interest that might be considered prejudicial to his/her independence.

The jobholder will be required to carry out his/her duties and conduct him/herself solely with the interests of the European Union in mind; he/she shall neither seek nor take instruction from any government, authority, organisation or person outside his/her institution. He/she shall carry out the duties assigned with objectivity, impartiality and loyalty to the European Union.

### Commitment to promote equal opportunities:

## 9. DATA PROTECTION
