# 1. THE GSA AND THE HUMAN RESOURCES DEPARTMENT

The European GNSS Agency (GSA) is responsible for the operations and service provision for the European Global Navigation Satellite Systems (GNSS) EGNOS and Galileo. By developing a new generation of GNSS, Europe is laying the foundation for new high-technology industry development, leading to job creation and economic growth. These European flagship space programmes, which embody what can be achieved when Europe works together, are already bringing real benefits to people and business in Europe and around the world.

The GSA's core mission is to ensure that European citizens get the most out of Europe's satellite navigation programmes. The Agency does this by:

- Ensure support for common culture and positive team spirit
- Provide sustainable support to staff members and their families
- Provide a safe working environment
- Provide strategic expertise to GSA governance and be important partner in achieving the GSA's vision, mission and objectives



# 2. TASKS AND RESPONSIBILITIES

The Human Resources Officer will report to the Head of Department or team leaders. Working with a degree of autonomy, the Human Resources Officer will coordinate and support key projects together with the team leaders in one, or more, areas of competence.

Depending on the area(s) of assignment, the duties of the Human Resources Officer will include the following non-exhaustive list of tasks:

### Selection and recruitment

- Define and implement the annual recruitment plan for the Agency, identifying the profiles needed and devising appropriate recruitment strategies
- Coordinate timely recruitment of suitably qualified staff, in accordance with internal procedures and EU rules and standards
- Organise and manage selections for all types of positions including production of required documentation and communication with candidates
- Provide advice and guidance on selection and recruitment procedures and participate in selection boards

#### Learning and development

- Manage the design, implementation, monitoring and coordination of learning and development activities
- Administer individual learning and development activities and databases in line with valid rules and provide the administrative follow-up of training requests
- Monitor contracts and liaise with relevant training providers
- Provide feedback, reports and data analysis on training needs and achievements and provide guidance in designing learning activities
- Organise and monitor social activities
- Organise, monitor and support performance management ensuring its timely execution (annual appraisal exercise, objectives set-up, reclassification exercises)

### Personnel administration and services

- Organise and manage administrative procedures for staff entering or leaving the Agency
- Coordinate the establishment and follow up on staff individual rights, benefits, obligations and contractual conditions
- Ensure timely payment of staff salaries and allowances and sound financial management of the Agency's HR-related budget
- Manage absences and working conditions

### General responsibilities

- Ensure the correct application of the EU Staff Regulations and Conditions of Employment of Other Servants of the European Union (CEOS) as well as relevant implementing rules
- Develop, review and update the Agency's HR policies, policy instruments and procedures, and ensure their correct implementation
- Provide support to management and staff in the interpretation of rules, as well as guidance, information and advice on the implementation of HR policies and procedures
- Ensure and promote compliance of HR related data protection rules
- Draft and update quality management documents for HR processes
- Prepare public procurement and tender procedures in the relevant areas of responsibility



- Manage HR related contracts
- Organise and manage HR Archives (electronic & paper)
- Liaise with relevant services in the European Commission and other EU Institutions and Agencies on issues related to the HR function
- Ensure and promote smooth communications and liaison with the Agency staff and staff representatives on HR matters
- As HR ambassador promote good working culture and team spirit within the Agency



# 3. PROFESSIONAL QUALIFICATIONS AND OTHER REQUIREMENTS

## **A.** ELIGIBILITY CRITERIA

The selection procedure is open to applicants who satisfy the following eligibility criteria, on the closing date for application:

- Have a level of education which corresponds to completed university studies<sup>5</sup> of at least three years attested by a diploma and appropriate professional experience<sup>6</sup> of at least one year after obtaining the final diploma
- 2. Be a national of a Member State of the European Union or Norway
- 3. Be entitled to his or her full rights as citizen
- 4. Have fulfilled any obligations imposed by the applicable laws concerning military service
- 5. Meet the character requirements for the duties involved<sup>7</sup>
- 6. Have a thorough knowledge of one of the languages of the European Union<sup>8</sup> and a satisfactory knowledge of another language of the European Union to the extent necessary for the performance of his/her duties
- 7. Be physically fit to perform the duties linked to the post<sup>9</sup>

# **B.** SELECTION CRITERIA

All eligible applications, according to the afore-mentioned criteria (part A), will be assessed against the requirements listed below. The Selection Board responsible for this selection will determine the criteria to be assessed in the various phases of the selection procedure (assessment of the application forms, interview and written test) prior to being granted access to the names of the applicants. At least all essential criteria will be assessed during the applications evaluation phase.

Please note that non-compliance with any of the essential requirements (B.1) will result in exclusion of the candidate from the selection process.

Advantageous requirements (B.2) constitute additional assets and will not result in exclusion, if not fulfilled.

### 1) Essential qualifications and experience

- i. Experience relevant to the HR areas and tasks mentioned above, preferably gained within an international environment
- ii. Knowledge and/or experience in dealing with the European Union Staff Regulations, its implementing rules, policies and procedures
- iii. Experience in coordinating HR activities and projects
- iv. Very good command of both written and spoken English

### 2) Advantageous qualifications and experience

- v. Experience and/or knowledge of HR IT applications, tools and/or databases
- vi. Experience in HR-related procurement and budgetary matters

### 3) Behavioural competencies

- vii. Motivation
- viii. Excellent communications skills
- ix. Sense of confidentiality and outstanding professional integrity
- x. Empathy, service culture and ability to maintain good interpersonal relations at work
- xi. Ability to work under pressure and within tight deadlines and prioritise tasks
- xii. Strong sense of initiative and problem solving oriented approach

# **4. SELECTION PROCEDURE**

The selection procedure includes the following steps:

- After registration, each application will be checked in order to verify that it meets the eligibility criteria.
- All eligible applications will be evaluated by a Selection Board based on the selection criteria defined in this vacancy notice.
- The candidates whose applications rank among the best-qualified in accordance with the selection criteria, may be contacted in order to verify (through an oral or written test) their studies, professional experience and/or other knowledge and competencies as indicated in their application form. This contact would be an intermediate step in pre-selecting the most suitable candidates. It does not however entitle candidates to be invited for an interview. The best-qualified candidates, those who obtained the highest number of points within the evaluation, will be short-listed for an interview. The minimum threshold is 65% of the total points.



- During the interview, the Selection Board will examine each candidate's profile and will assess their relevancy for this post. In order to support the evaluation via interview, shortlisted candidates will be required to undergo a computer-based written test relevant to the job content (the minimum threshold for this test is 50% of the total points allocated for it) and to complete part of the process in their second EU language. All candidates short-listed for an interview will also be requested to complete an online Business Attitude Questionnaire.
- Candidates will be requested to bring with them on the day of the interview photocopies of all the supporting documents for their educational qualifications and employment necessary to prove that they meet the eligibility criteria. GSA has the right to disqualify applicants who fails to submit all the required documents.
- As a result of the interviews, the Selection Board will recommend the most suitable candidate(s) for this post to be placed on a reserve list. The minimum threshold to be placed on the reserve list is 65% of the total points.
- The reserve list will be presented to the Appointing Authority who ultimately may appoint the successful candidate to the post.
- The established reserve list may also be used for recruitment of similar posts depending on the Agency's needs. Where a similar post becomes available, the Appointing Authority may select applicants from the list according to their profile in relation to the specific requirements of the post to be filled. However, inclusion on the reserve list does not guarantee recruitment.
- If, at any stage of the procedure, it is established that any of the information the candidate provided is incorrect, the candidate in question will be disqualified.

Indicative date for the interview and written test<sup>10</sup>: May 2018

Candidates are strictly forbidden to make any contact with the Selection Board members, either directly or indirectly. Any infringement of this rule will lead to disqualification from the selection procedure.

# **5. APPLICATION PROCEDURE**

For applications to be considered valid, candidates must submit an email to <u>GSAjobsHR@gsa.europa.eu</u> with a subject line of 'SURNAME\_Name\_Vacancy Reference Number' which contains the Agency's approved application form (Download it here: <u>http://www.gsa.europa.eu/gsa/job-opportunities</u>).

This form must be:

- Completed in English
- Fully completed, pointing out the professional experience relevant to this position (incl. calculation of years, months)
- Printed, signed and clearly scanned in (in one single document)
- Named as follows: SURNAME\_Name\_Vacancy Ref. number (e.g. SPENCER\_Marc\_GSA.2018.123)

The application will be rejected if it is not duly completed and signed.

Further supporting documents showing evidence of the information given in the application will be requested at a later stage.

No documents will be sent back to candidates.

Applications must be sent to <u>GSAjobsHR@gsa.europa.eu</u> and received by the deadline listed on page 01 of this vacancy notice at the latest, clearly indicating the vacancy reference number in the subject line.

Applications sent after the deadline will not be considered.

Candidates are reminded not to wait until the final days before the closing date of applications' submissions. The Agency cannot be held responsible for any last-minute malfunction due to any overflow of the mailbox.

# 6. APPEAL PROCEDURE

If a candidate considers that he/she has been adversely affected by a particular decision, he/she can:

• lodge a complaint under Article 90(2) of the Staff Regulations of Officials of the European Communities and Conditions of employment of other servants of the European Communities, at the following address:

Please note also that, under Article 2(4) of the general conditions governing the performance of the Ombudsman's duties, any complaint lodged with the Ombudsman must be preceded by the appropriate administrative approaches to the institutions and bodies concerned.



# 7. SUMMARY OF CONDITIONS OF EMPLOYMENT

# I. FINANCIAL ENTITLEMENTS

The remuneration consists of a basic salary<sup>11</sup> and, where applicable, additional allowances<sup>12</sup>, paid on a monthly basis and reimbursements<sup>13</sup>, paid upon their evidenced occurrence.

The sum of the basic salary and the applicable additional allowances is weighted by the correction coefficient applicable for the location of the post<sup>14</sup>. The sum of usual social deductions from salary at source is subtracted from the weighted amount<sup>15</sup>. The full pay is exempted from the national income tax, but is subject to the internal income tax and the solidarity levy<sup>16</sup>.

### **II. LEAVE ENTITLEMENTS**

Staff is entitled to annual leave of two working days per each complete calendar month of service plus additional days for the grade, age, home leaves for expatriates and an average of 16 GSA public holidays per year.

Special leave is granted for certain circumstances such as marriage, moving, elections, birth or adoption of a child, serious sickness of spouse, etc.

### **III. SOCIAL SECURITY**

The pension scheme provides a very competitive pension after a minimum of 10 years of service and reaching the pensionable age. Pension rights acquired in one or more national schemes before starting to work at GSA may be transferred into the EU pension system.

GSA's benefits include an attractive Health insurance: staff is covered 24/7 and worldwide by the Joint Sickness Insurance Scheme (JSIS). Staff is insured against sickness, accident and occupational disease, and could be entitled to unemployment and to invalidity allowances.

### IV. PROFESSIONAL DEVELOPMENT AND BENEFITS CONTRIBUTING TO WORK-LIFE BALANCE

GSA aims at creating and maintaining a supportive and healthy work environment that enables staff members to have balance between work and personal responsibilities, for example through flexible working time arrangements.

GSA also offers a wide range of training courses to develop staff members' personal skills and keep in touch with the latest developments in their field. The training and professional development opportunities are attuned to the career plan and requirements of the departments.
