#### 1. THE GSA AND THE MARKET DEVELOPMENT DEPARTMENT

The European GNSS Agency (GSA) is responsible for the operations and service provision for the European Global Navigation Satellite Systems (GNSS) EGNOS and Galileo. By developing a new generation of GNSS, Europe is laying the foundation for new high-technology industry development, leading to job creation and economic growth. These European flagship space programmes, which embody what can be achieved when Europe works together, are already bringing real benefits to people and business in Europe and around the world.

The GSA's core mission is to ensure that European citizens get the most out of Europe's satellite navigation programmes. The Agency does this by:

- Designing and enabling services that fully respond to user needs, while continuously improving the European GNSS services and infrastructure
- · Managing the provision of services that ensure user satisfaction in the most cost efficient manner
- Engaging market stakeholders to develop innovative and effective applications, value-added services and user technology that promote the achievement of full European GNSS adoption
- Ensuring that European GNSS services and operations are thoroughly secure, safe and accessible

In this context, the Market Development Department main responsibilities are related to develop the market, innovative applications, value-added services and user technology that promote the achievement of full European GNSS adoption, ensuring at the same time that the European GNSS services answer to current and future user needs. Market Development main pillars are:

- Understanding the users, the market and the user-related technologies (for example via the publication of the GNSS Market Report, the GNSS User Technology Report and the User Consultation Platform)
- Fostering the creation of European GNSS market demand, engaging the main user communities, building and implementing adoption roadmaps, capturing the user needs and feedbacks for improving current services and designing the next generation of services
- Creating a competitive EU offer of applications and products that answer the demand, in particular via the Research and Innovation tools, delegated by the European Commission, and fostering the EU industry and SMEs
- The Market Development Department is organised by vertical market segments (e.g. Road, Rail, Maritime, LBS, Mapping & Surveying, etc.) that require specific expertise, supported by horizontal functions, e.g. the Research and Innovation coordination.

#### 2. TASKS AND RESPONSIBILITIES

The Market Development Innovation Officer will actively contribute to the fulfilment of the Agency's duties related to the implementation of market development activities.

His/her tasks and responsibilities shall in principle include (without limitation):

- Monitor the market and analyse attractiveness, trends, industry value chain, competing and complementary technology
- Analyse user needs and translate them into user requirements by performing ad hoc market research and coordinate user and stakeholder communities
- Evaluate the E-GNSS value proposition and identify key differentiators for the users
- Foster application development by managing the R&D applications within the European Commission R&D Horizon 2020 programme
  - o Contribute to the preparation of calls for proposal and the selection of projects
  - o Manage projects and perform technical monitoring and appraisal of results
  - Manage reporting on projects status and identify suggested actions
  - o Ensure widest awareness and disseminate project results
- Manage technical R&D projects, aiming at developing new EGNSS solutions and products with particular focus on applications and receiver technology
- Analyse results of application market user tests
- Define the downstream market entry strategy actions for specific market segment(s)
- Cooperate with the value chain (e.g. receiver manufacturers, application developers, service providers)
- Manage the interface with receiver and chipset manufacturers to integrate EGNSS in their products, collect user requirements and ensure adoption
- Identify user needs to facilitate the design of new services or evolutions of current services of EGNSS by the Service Engineering teams
- Implement market development actions, giving highest priority to those most leveraging EGNSS differentiators for the users
- Act as the entry point for key market stakeholders in specific market segments
- Ensure user assistance and information/Customer Relationship Management (CRM) for EGNSS services
- Monitor user satisfaction, performing surveys for EGNSS services
- Support application developers and service providers, willing to invest in Galileo and EGNOS applications and services, with special focus on Small and medium-sized enterprises (SMEs)
- Manage projects and studies, involving internal teams and/or contractors, including the definition of the scope of work, preparation of tender documentation, evaluation of bids, negotiation of contracts and ensuring successful execution of related actions
- Support the Market Development team in the preparation of regular reporting
- Contribute to the overall GSA processes such as quality management and reporting
- Contribute to other tasks of the Market Development Department as deemed necessary



# 3. PROFESSIONAL QUALIFICATIONS AND OTHER REQUIREMENTS

#### A. ELIGIBILITY CRITERIA

The selection procedure is open to applicants who satisfy the following eligibility criteria, on the closing date for application:

- 1. Have a level of education which corresponds to completed university studies<sup>5</sup> of at least three years attested by a diploma and appropriate professional experience<sup>6</sup> of at least one year after obtaining the final diploma
- 2. Be a national of a Member State of the European Union or Norway
- 3. Be entitled to his or her full rights as citizen
- 4. Have fulfilled any obligations imposed by the applicable laws concerning military service
- 5. Meet the character requirements for the duties involved<sup>7</sup>
- 6. Have a thorough knowledge of one of the languages of the European Union<sup>8</sup> and a satisfactory knowledge of another language of the European Union to the extent necessary for the performance of his/her duties
- 7. Be physically fit to perform the duties linked to the post<sup>9</sup>

#### B. SELECTION CRITERIA

All eligible applications, according to the afore-mentioned criteria (part A), will be assessed against the requirements listed below. The Selection Board responsible for this selection will determine the criteria to be assessed in the various phases of the selection procedure (assessment of the application forms, interview and written test) prior to being granted access to the names of the applicants. At least all essential criteria will be assessed during the applications evaluation phase.

Please note that non-compliance with any of the essential requirements (B.1) may result in exclusion of the candidate from the selection process.

Advantageous requirements (B.2) constitute additional assets and will not result in exclusion, if not fulfilled.

#### 1) Essential requirements

- University degree preferably in engineering (e.g. GNSS, telecommunications, electronics, aeronautics) or in economics, business and/or in a scientific field; OR another degree only if accompanied by a subsequent MBA or relevant specialisation (e.g. Master in GNSS, business related fields)
- ii. Experience in innovation, R&D and/or market entry strategy and implementation of related actions with a proven record of innovation and business results
- iii. Project management experience, in particular, experience managing external contractors and international teams
- iv. Very good command of both written and spoken English

## 2) Advantageous requirements

- v. Experience gained in complex organisations and/or in the EU institutional environment
- vi. Experience in identifying user needs and translate them into user requirements during product or service definition
- vii. Knowledge of the GNSS (including receiver technology) and its application market segments, in particular transport, high precision and/or other related ones such as telecommunications and IT

#### 3) Behavioural competencies

- viii. Motivation, fascinating vision of the job and excellent drive to make results come true
- ix. Excellent analytical skills
- x. Excellent communication skills
- xi. Stress management and flexibility in adapting to a fast paced environment
- xii. Ability to manage project teams

## 4. SELECTION PROCEDURE

The selection procedure includes the following steps:

- After registration, each application will be checked in order to verify that it meets the eligibility criteria.
- All eligible applications will be evaluated by a Selection Board based on the selection criteria defined in this vacancy notice.
- The candidates whose applications rank among the best-qualified in accordance with the selection criteria, may be contacted in order to verify (through an oral or written test) their studies, professional experience and/or



other knowledge and competencies as indicated in their application form. This contact would be an intermediate step in pre-selecting the most suitable candidates. It does not however entitle candidates to be invited for an interview. The best-qualified candidates, those who obtained the highest number of points within the evaluation, will be short-listed for an interview. The minimum threshold is 65% of the total points.

- During the interview, the Selection Board will examine each candidate's profile and will assess their relevancy for this post. In order to support the evaluation via interview, shortlisted candidates will be required to undergo a computer-based written test relevant to the job content (the minimum threshold for this test is 50% of the total points allocated for it) and to complete part of the process in their second EU language. All candidates short-listed for an interview will also be requested to complete an online Business Attitude Questionnaire.
- Candidates will be requested to bring with them on the day of the interview photocopies of all the supporting documents for their educational qualifications and employment necessary to prove that they meet the eligibility criteria. GSA has the right to disqualify applicants who fails to submit all the required documents.
- As a result of the interviews, the Selection Board will recommend the most suitable candidate(s) for this post to be placed on a reserve list. The minimum threshold to be placed on the reserve list is 65% of the total points.
- The Appointing Authority will ultimately decide on the successful candidate to be placed on the reserve list and to be appointed to the post.
- The established reserve list may also be used for recruitment of similar posts depending on the Agency's needs. Where a similar post becomes available, the Appointing Authority may select applicants from the list according to their profile in relation to the specific requirements of the post to be filled. However, inclusion on the reserve list does not guarantee recruitment.
- If, at any stage of the procedure, it is established that any of the information the candidate provided is incorrect, the candidate in question will be disqualified.

Indicative date for the interview and written test<sup>10</sup>: September/October 2018

Candidates are strictly forbidden to make any contact with the Selection Board members, either directly or indirectly. Any infringement of this rule will lead to disqualification from the selection procedure.

#### 5. APPLICATION PROCEDURE

This form must be:

- Completed in English
- Fully completed, pointing out the professional experience relevant to this position (incl. calculation of years, months)
- Printed, signed and clearly scanned in (in one single document)
- Named as follows: SURNAME\_Name\_Vacancy Ref. number (e.g. SPENCER\_Marc\_GSA.2018.123)

The application will be rejected if it is not duly completed and signed.

Further supporting documents showing evidence of the information given in the application will be requested at a later stage.

No documents will be sent back to candidates.

Applications sent after the deadline will not be considered.

### 6. APPEAL PROCEDURE

If a candidate considers that he/she has been adversely affected by a particular decision, he/she can:

• lodge a complaint under Article 90(2) of the Staff Regulations of Officials of the European Communities and Conditions of employment of other servants of the European Communities, at the following address:

Please note also that, under Article 2(4) of the general conditions governing the performance of the Ombudsman's duties, any complaint lodged with the Ombudsman must be preceded by the appropriate administrative approaches to the institutions and bodies concerned.



### 7. SUMMARY OF CONDITIONS OF EMPLOYMENT

#### I. FINANCIAL ENTITLEMENTS

The remuneration consists of a basic salary<sup>11</sup> and, where applicable, additional allowances<sup>12</sup>, paid on a monthly basis and reimbursements<sup>13</sup>, paid upon their evidenced occurrence.

The sum of the basic salary and the applicable additional allowances is weighted by the correction coefficient applicable for the location of the post<sup>14</sup>. The sum of usual social deductions from salary at source is subtracted from the weighted amount<sup>15</sup>. The full pay is exempted from the national income tax, but is subject to the internal income tax and the solidarity levy<sup>16</sup>.

## **II. LEAVE ENTITLEMENTS**

Staff is entitled to annual leave of two working days per each complete calendar month of service plus additional days for the grade, age, home leaves for expatriates and an average of 16 GSA public holidays per year.

Special leave is granted for certain circumstances such as marriage, moving, elections, birth or adoption of a child, serious sickness of spouse, etc.

#### III. SOCIAL SECURITY

The pension scheme provides a very competitive pension after a minimum of 10 years of service and reaching the pensionable age. Pension rights acquired in one or more national schemes before starting to work at GSA may be transferred into the EU pension system.

GSA's benefits include an attractive Health insurance: staff is covered 24/7 and worldwide by the Joint Sickness Insurance Scheme (JSIS). Staff is insured against sickness, accident and occupational disease, and could be entitled to unemployment and to invalidity allowances.

#### IV. PROFESSIONAL DEVELOPMENT AND BENEFITS CONTRIBUTING TO WORK-LIFE BALANCE

GSA aims at creating and maintaining a supportive and healthy work environment that enables staff members to have balance between work and personal responsibilities, for example through flexible working time arrangements.

GSA also offers a wide range of training courses to develop staff members' personal skills and keep in touch with the latest developments in their field. The training and professional development opportunities are attuned to the career plan and requirements of the departments.

#### 8. COMMITMENT
