Duties

Reporting to the Head of Section and within the technical fields described above, the main tasks and responsibilities of the post holder will include:

- providing expert technical support and consultancy to ESA projects, programmes and general studies in the field of
 materials and processes throughout all project phases, with a particular focus on, but not limited to, composite and
 metallic materials, related bonding and joining processes, material/process relationships, predictive performance
 modelling, process/product verification, defect analysis, etc.;
- participating in feasibility studies, project reviews and evaluation of procurement proposals;
- reviewing Materials, Mechanical Parts and Processes Lists of ESA Programmes in the framework of the Materials and Processes Review Boards;
- identifying critical development problems and assisting in their resolution;
- contributing to the definition of technology development requirements and work plans for the Agency
